

ORDINANCE NO. 27

AN ORDINANCE DECLARING THE INTENTION OF THE CITY OF LAKESIDE, COOS COUNTY, OREGON, TO ANNEX CONTIGUOUS TERRITORY AND ELECTING TO DISPENSE WITH THE SUBMISSION OF SUCH ANNEXATION TO THE LEGAL VOTERS OF THE CITY; AND CALLING AND MAKING PROVISIONS FOR A PUBLIC HEARING UPON SAID ANNEXATION.

THE CITY OF LAKESIDE ORDAINS AS FOLLOWS:

Section 1. The Council of the City of Lakeside hereby declares its intention to annex to said City certain real property contiguous thereto which is described as follows, to-wit:

A tract of land in SW ^f1/4 NW 1/4, Section 17, Township 23 South, Range 12 West of the Willamette Meridian described as follows:

Beginning at a 3/4" iron pipe which is the C.S. 1/4 corner of Section 17, T 23 S, R 12 W, W.M.; thence N 23 degrees 07' 36" W a distance of 346.29 feet; thence N 09 degrees 15' E a distance of 95.00 feet to a 3/4" iron pipe; thence S 60 degrees 30' E a distance of 154.48 feet to a 3/4" iron pipe; thence S 2 degrees 15' W a distance of 350.00 feet to the point of beginning, said parcel containing 0.75 acres.

Section 2. The Council of the City of Lakeside hereby elects to dispense with the submission of the said question of annexation to the legal voters of the City of Lakeside; and does hereby call a hearing to be held at the hour of 7:30 p.m. on the 16th day of March, 1978, at the Lakeside Water District office in the City of Lakeside, Oregon, at which time the registered voters of the City of Lakeside, Oregon may appear and be heard upon the question of said annexation.

Section 3. The Recorder of the City of Lakeside is hereby directed to publish notice of said public hearing once each week for two successive weeks in the Lakeside area in a newspaper of general circulation in the City of Lakeside, and

to post said notice in four public places within said City at or before the time of the first publication and until said hearing.


Section 4. The Council finds that this ordinance is necessary to protect the health, safety and welfare of the City and the annexing property owner and, therefore, an emergency exists so that this ordinance shall become effective immediately upon its passage.

The forgoing ordinance was duly passed by the Council of the City of Lakeside, Oregon on the 3rd day of March, 1978.


