

ORDINANCE NUMBER 40

AN ORDINANCE PROVIDING FOR AN ELECTION FOR THE PURPOSE OF AUTHORIZING THE CITY TO LEVY A SERIAL TAX FOR THE YEAR 1979-80.

THE CITY OF LAKESIDE ORDAINS AS FOLLOWS:

Section 1. An election shall be held within the City of Lakeside, Coos County, Oregon on the 14th day of August, 1979. The question of authorizing the City to levy a serial tax of \$51,089.00 to fund the operation of the City for the tax year 1979-80 shall be submitted to the voters of the City.

Section 2. The funds to be provided by this tax levy are to be used and expended to provide City services and to operate the City for the fiscal year 1979-80. The estimated total outlay for the operation of the City in said fiscal year is \$51,089.00. The levy sought to be authorized is for a period of one year. The proposed tax levy is outside the six percent limitation imposed by Section 11, Article XI, Oregon Constitution, and is subject to the vote of the citizens of the City.

Section 3. The ballots for said election shall be in substantially the following form:

(Vote by marking "✓" or "X" in the box opposite "NO" if you vote against

the tax and in the box opposit "YES"
if you vote for the tax.)

- (#) Shall the City of Lakeside be authorized YES
to levy a serial tax in the amount of
\$51,089.00 for the tax year 1979-80 to
finance the operating budget of the NO
City. Said levy shall be for one year
only.

Section 4. The polling place for said election shall be at
the Senior Citizens Center located on 202 North 8th Street within said
City. Said polling place shall remain open between the hours of 8 o'clock
A. M. and 8 o'clock P. M. on said election day.

Section 5 The election board shall consist of those persons
appointed and acting as the City precinct election board pursuant to
ORS 246.310 on the date of said election.

Section 6. The Recorder of said City shall prepare the
sample and official ballots for said election. The Election Officer
shall make arrangements for said election, and if any member of the
Board of Election shall be unwilling or unable to serve as such, shall
appoint a qualified substitute.

Section 7. The Recorder shall cause notice of the City
Election to be posted in three conspicuous places within said District
for a period of not less than 10 days prior to the date of holding said
City Election.

Section 8. The Council finds that an emergency

exists which, in order to fund the City's 1979-80 operating budget, requires that this ordinance shall take effect immediately upon its passage by the Council and it being signed by the Mayor.

Section 9. "The World" is designated as the newspaper in which all publications shall be made.

The foregoing ordinance was duly passed by the City Council of the City of Lakeside on this 18 day of July, 1979.
