

ORDINANCE NO. 55

AN ORDINANCE PROVIDING FOR THE CALLING OF A CITY ELECTION IN THE CITY OF LAKESIDE, OREGON ON JUNE 24, 1980 FOR THE PURPOSE OF SUBMITTING TO THE LEGAL VOTERS OF THE CITY OF LAKESIDE, OREGON, THE QUESTION OF AUTHORIZING THE CITY OF LAKESIDE TO LEVY A ONE YEAR "B" BALLOT PROPERTY TAX LEVY FOR OPERATING PURPOSES.

WHEREAS, The City Council of the City of Lakeside, Oregon has determined that a "B" Ballot property tax levy should be established in accordance with Article XI, Section 11, Oregon Constitution, for the general operation of the City of Lakeside for fiscal year 1980-1981.

AND WHEREAS, it is necessary to submit the question of establishing a "B" Ballot property tax levy to the legal voters of the City of Lakeside, Oregon.

NOW THEREFORE,

THE CITY OF LAKESIDE ORDAINS AS FOLLOWS:

Section 1. Date of Election. The proposition set forth in Section 2 of this ordinance shall be submitted in the manner prescribed in this ordinance to the legal voters of the City of Lakeside, Oregon, at a City "A" and "B" tax levy election to be held on June 24, 1980.

Section 2. Form of Proposition. At the City "A" and "B" tax levy election there shall be submitted to the legal voters of the City of Lakeside, for their approval or rejection, the following proposition:

ONE YEAR "B" BALLOT PROPERTY TAX LEVY FOR OPERATING PURPOSES. Shall the City of Lakeside be authorized to levy \$65,434.00 outside the tax base for financing City operations during fiscal year 1980-1981?

STATEMENT OF PURPOSE. To levy a tax according to Article XI Section 11, Oregon Constitution, for the general operation of the City of Lakeside, fiscal year 1980-1981. The levy sought is to be for operation of the City of Lakeside, and will be levied in the fiscal year 1980-1981.

EXPLANATION. If this measure is approved, \$65,434.00 of the taxes levied will be financed totally by local tax payers without any partial state payment. An additional sum of \$58,803.00 will be needed for full operation of the City of Lakeside for fiscal year 1980-1981 and is being submitted on the "A" Ballot for the consideration of the voters. This "B" Ballot levy of \$65,434.00 cannot be imposed unless the "A" Ballot levy also passes. A decrease in revenues from Federal Revenue Sharing, State Tax Street Funds, and CETA has made necessary an increased tax levy.

Section 3. Election Part of Special District Election. There is a special district election being held in the County of Coos and in the City of Lakeside on June 24, 1980 and this City "A" and "B" tax levy election is called to be held currently therewith, and as a part thereof.

Section 4. Election Boards. The City "A" and "B" tax levy election shall be handled by, and the City "A" and "B" levy Ballots counted by, the same election boards that handle the special district election in the election precincts in which the City of Lakeside is located at the special district election to be held on June 24, 1980. Such election boards hereby are designated as the election boards for the City "A" and "B" tax levy election and shall hold their respective offices as designated for the special district election.

Section 5. Voting Hours. The polls for the City "A" and "B" tax levy election shall be opened in each of the voting precincts at the same hour, and shall be kept open until the same hour, as the polls are opened and closed for the special district election that will be held on the same day.

Section 6. Qualified Voters. The election boards handling the election shall permit only those electors to vote on the question of establishing a City "A" and "B" tax levy who are otherwise qualified to vote at the special district election and who reside within the boundaries of the City of Lakeside.

Section 7. Notice of Election. Notice of the City "A" and "B" tax levy election shall be given by publication twice in The World, a newspaper of general circulation in the City of Coos Bay, Oregon, not more than 30 nor less than 10 days before the election. Notices of the City "A" and "B" tax levy election shall be posted for no less than 20 days before the election in three public places within the City. The notice in the newspaper and that posted in three public places shall be in substantially the following form:

NOTICE OF MEASURE ELECTION
CITY OF LAKESIDE

Notice is hereby given that on Tuesday, June 24, 1980, an election will be held in the City of Lakeside, Coos County, Oregon. The polls will be open from 8:00 A.M. to 8:00 P.M. The following question shall be submitted to the qualified voters thereof:

ONE YEAR "B" BALLOT PROPERTY TAX LEVY FOR OPERATING PURPOSES. "Shall the City of Lakeside be authorized to levy \$65,434.00 outside the tax base for financing City operations during fiscal year 1980-1981?"

STATEMENT OF PURPOSE. To levy a tax according to Article XI Section 11, Oregon Constitution, for the City of Lakeside, fiscal year 1980-1981. The levy sought is to be for operation of the City of Lakeside, and will be levied in the fiscal year 1980-1981.


EXPLANATION. If the measure is approved \$65,434.00

STATEMENT OF PURPOSE. To levy a tax according to Article XI Section 11, Oregon Constitution, for the City of Lakeside, fiscal year 1980-1981. The levy sought is to be for operation of the City of Lakeside, and will be levied in the fiscal year 1980-1981?


EXPLANATION. If the measure is approved, \$58,803.00 of the taxes levied will be financed partially by the State of Oregon, which will result in an estimated tax rate of \$2.71 per \$1,000.00 of assessed value exclusive of levies for bond principal and interest and serial levies for capital construction. An additional sum of \$65,434.00 will be needed for full operation of the City of Lakeside for the fiscal year 1980-1981 and is being submitted on the "B" Ballot for the consideration of the voters. The additional sum, if approved, will result in a combined tax rate of \$5.73 per \$1,000.00 of assessed valuation and will provide for the total operation of the City. The additional sum of \$65,434.00 being requested on the "B" Ballot cannot be imposed unless this "A" Ballot passes. A decrease in revenues from Federal Revenue Sharing, State Tax Street Funds, and CETA has made necessary an increased tax levy.

The foregoing ordinance is duly passed by the Council of the City of Lakeside, Oregon and approved by the Mayor, this 15th day of May, 1980.
