AN ORDINANCE PROVIDING FOR THE CALLING OF A CITY ELECTION IN THE CITY OF LAKESIDE, OREGON ON MAY 19, 1981, FOR THE PURPOSE OF SUBMITTING TO THE LEGAL VOTERS OF THE CITY OF LAKESIDE, OREGON, THE QUESTION OF AUTHORIZING THE CITY OF LAKESIDE LIMIT FOR OPERATING PURPOSES, AND DECLARING AN EMERGENCY.

WHEREAS, the City Council of the City of Lakeside, Oregon, has determined that a "B" Ballot special levy property tax levy should be established in accordance with Article XI, Section 11, Oregon Constitution, for the general operation of the City of Lakeside for fiscal year 1981-1982.

AND WHEREAS, it is necessary to submit the question of establishing a one-year special levy property tax to the legal voters of the City of Lakeside, Oregon.

NOW THEREFORE, THE CITY OF LAKESIDE ORDAINS AS FOLLOWS:

Section 1. <u>Date of Election</u>. The proposition set forth in Section 2 of this ordinance shall be submitted in the manner prescribed in this ordinance to the legal voters of the City of Lakeside, Oregon, at a City one-year special levy election to be held on May 19,1981.

Section 2. Form of Proposition. At the City one-year special levy election there shall be submitted to the legal voters of the City of Lakeside, for their approval or rejection, the following proposition:

ONE YEAR "B" BALLOT PROPERTY TAX LEVY FOR OPERATING PURPOSES.

Question. Shall the City of Lakeside be authorized to levy \$14,292.00 outside the constitutional limit for maintaining current services.

Statement of Purpose. To levy a tax according to Article XI, Section 11, Oregon Constitution, for the general operation of the City of Lakeside, Fiscal year 1981-1982. The levy sought in the fiscal year 1981-1982.

Explanation. If this measure is approved, \$14,292.00 of the taxes levied will be financed totally by local taxpayers with out any partial state payment. A total tax levy of \$79,328.00 is needed to maintain current services of the City of Lakeside. \$65,036.00 of the \$79,328.00 is being submitted for voter consideration on the "A" Ballot. The additional sum needed, of \$14,292.00, if approved, will result in a combined tax rate levies for bond principal and interest and serial levies for capital construction. This "B" Ballot levy of \$14,292.00 cannot be levied unless the "A" Ballot levy also passes.

Section 3. <u>Election Part of Special District Election</u>. There is a special district election being held in the County of Coos and in the City of Lakeside on May 19, 1981, and this City one-year special levy election is called to be held currently therewith, and as a part thereof.

Section 4. Election Boards. The City one-year special levy election shall be handled by, and the City Ballots counted by, the same election boards that handle the special district election in the election precincts in which the City of Lakeside is located at the special district election to be held on May 19, 1981. Such election boards hereby are designated as the election boards for the City one-year special levy election and shall hold their respective offices as designated for the special district election.

Section 5. <u>Voting Hours</u>. The polls for the City one-year special levy election shall be opened in each of the voting precincts at the same hour and shall be kept open until the same hours, as the polls are opened and closed for the special district election that will be held on the same day.

Section 6. Qualified Voters. The election boards handling the election shall permit only those electors to vote on the question of establishing a City one-year special levy who are otherwise qualified to vote at the special district election and who reside within the boundaries of the City of Lakeside.

Section 7. Notice of Election. Notice of the City of Lakeside one-year special levy election shall be given by publication in The World, a newspaper of general circulation in the City of Coos Bay, Oregon, not more than 30 nor less than 10 days before the election. Notices of the City one-year special levy election shall be posted for no less than 20 days before the election in three public places within the City. The Notice in the newspaper and that posted in three public places shall be in substantially the following form:

NOTICE OF MEASURE ELECTION

CITY OF LAKESIDE

Notice is hereby given that on May 19, 1981, an election will be held in the City of Lakeside, Coos County, Oregon. The polls will be open from 8:00 a.m. to 8:00 p.m. The following question shall be submitted to the qualified voters thereof:

ONE YEAR "B" BALLOT PROPERTY TAX LEVY FOR OPERATING PURPOSES.

Question. Shall the City of Lakeside be authorized to levy \$14,292.00 outside the constitutional limit for maintaining current services.

Statement of Purpose. To levy a tax according to Article XI, Section 11, Oregon Constitution, for the City of Lakeside, fiscal year 1981-1982. The levy sought is to be for continued operation of the City of Lakeside, and will be levied in the fiscal year 1981-1982.

Explanation. If this measure is approved, \$14,292.00 of the taxes levied will be financed totally by local taxpayers without any partial state payment. A total tax levy of \$79,328.00 is needed to maintain current services of the City of Lakeside. \$65,036.00 of the \$79,328.00 is being submitted for voter consideration on the "A" Ballot. The additional sum needed, \$14,292.00, if approved, will result in a combined tax rate of \$3.66 per \$1,000.00 of assessed valuation, exclusive of levies for bond principal and interest and serial levies for capital construction. This "B" Ballot levy of \$14,292.00 cannot be levied unless the "A" Ballot levy also passes.

Section 8. An emergency is declared to exist so that this ordinance comes effective immediately upon its passage and signing by the mayor because of the time remaining prior to the special district election.

The foregoing ordinance is duly passed by the Council of the City of Lakeside, Oregon, and approved by the Mayor, this 10th day of April, 1981.
