AM ORDINANCE PROVIDING FOR THE CALLING OF A CITY ELECTION IN THE CITY OF LAKESIDE, OREGON ON JUNE 30, 1901, FOR THE PURPOSE OF SUBMITTING TO THE LEGAL VOTERS OF THE CITY OF LAKESIDE, OREGON, THE QUESTION OF AUTHORIZING THE CITY OF LAKESIDE TO LEVY ON THE "A" BALLOT A SPECIAL LEVY PROPERTY TAX OUTSIDE THE CONSTITUTION OF LIMIT FOR OPERATING PURPOSES, AND DECLARING AN EMERGENCY.

whereas, the City Council of the City of Lakeside, Oregon has determined that an "A" Ballot Special levy property tax levy should be established in accordance with Article XI, Section 11, Oregon Constitution, for the general operation of the City of Takeside for fiscal year 1981-1982.

AND WHEREAS, it is necessary to submit the question of establishing a one year special levy property tax to the legal voters of the City of Lakeside, Oregon.

NOW THEREFORE,
THE CITY OF LAKESIDE ORDAINS AS FOLLOWS:

Section 1. <u>Date of Election</u>. The proposition set forth in Section 2 of this ordinance shall be submitted in the manner prescribed in this ordinance to the legal voters of the City of Lakeside, Oregon, at a City one year special levy election to be held June 30, 1981.

Section 2. Form of Proposition. At the City one-year special levy election there-shall be submitted to the legal voters of the City of Lakeside, for their approval or rejection, the following proposition:

ONE YEAR "A" BALLOT PROPERTY TAW LEVY FOR OPERATING PURPOSES.

Question. Shall the City of Lakeside be authorized to levy.
\$65,036.00 outside the constitutional limit for providing essential services.

Statement of Puriose. To levy a tax according to Artice XI. Section 11, Oregon Constitution, for

the City of Lakeside, fiscal year 1981-1982. The levy sought is needed for continued operation of The Recorder's Office, Police Department and the Public Works Pepartment

Explanation. If this measure is approved. \$65,036.00 of the taxes levied during fiscal year 1981-1982 will be financed partially by the State of Creson. which will result in an estimated tax rate of \$3.00 for 1,000.00 if assessed valuation exclusive of levies for bond principal and infinistional serial levies for capital construction. A total cost of \$105,700.00 is needed to maintain current services and one full time patrolman: The additional sum \$240.670.00 is being submitted for your consideration on the "B" Ballot. The additional sum, result in a combined tax rate of

assessed valuation exclusive of levise for bond principal and interest and serial levies for capital constuction.

Section 3. <u>Election Part of Special District Election</u>.

There is a special district election being held in the County of Coos and in the City of Lakeside on June 30, 1981, and this City one—par special levy election is called to be held currently therewith, and as a part thereof.

Section 4. Election Boards. The City one-year special election shall be handled by, and the City Ballots counted by, the same election boards that handle the special district election in the election precincts in which the City of Lakeside is located at the special district election to be held on June 30, 1931. Such election boards hereby are designated as the election boards their respective offices as designated for the special district election.

Section 5. <u>Voting Hours</u>. The polls for the City one-year special levy election shall be opened in each of the voting precincts at the same hour, and shall be kept open until the same hour, as the polls are opened and closed at the special district election that will be held on the same day.

Section 6. Qualified Voters. The election boards handling the election shall permit only those electors to vote on the question of establishing a City one-year special lavy who are otherwise qualifito vote at the special district election and who reside within the boundaries of the City of Lakeside.

Section 7. Notice of Election. Notice of the City one-year special levy election shall be given by publication in the Worli, a newspaper of general circulation in the City of Coos Bay, Oregon, not more than 30 nor less than 10 days before the election. Notices of the City one-year special levy election shall be posted no less than 20 days before the election in three public places within the City. The notice in the newspaper and that posted in three public places shall be in substantially the following form:

NOTICE OF MEASURE ELECTION CITY OF LAKESIDE

Notice is hereby given that on June 30, 1981, on election will be held in the City of Lakeside, thos County, Oregon. The polls will be open from \$:000 A.M. to 8:00 P.M. The following question shall be submitted to the qualified voters thereof:

ONE YEAR "A" BALLOT PROPERTY TAX LEUY FOR OPERATING PURPOSES

to levy \$65,036.00 outside the constitutional limit for providing essential services.

Statement of Furzous. to leave a tax according to Article

II, Section II, Oregon Constitution, for the City of Lakesda

fiscal year 1931-1932. The levy sought is needed for continued operation of the Recorder's Office, Police Department, and Public Works Department.

Explanation. If this measure is approved, 15,036:00 of the taxes levied during fiscal year 1901-132 will be financed partially by the State of Oregon, which will result in an estimated tax rate of \$3.00 per \$1,000.00 of assessed valuation exclusive of levies for bond principal and interest and serial levies for capital construction. A total tax of \$105,706.00 is needed to maintain current services and add one full time petrolman. The additional sum needed, \$40,670.00 is being submitted for voter consideration on a "B" Ballot. The additional sum, if approved, will result in a combined tax rate of \$4.88 per \$1,000.00 of assessed valuation exclusive of levies for bond principal and interest and serial levies for capital construction.

Section 8. An emergency is declared to exist so that this ordinance becomes effective immediately upon its passage and signing by the Mayor because of the time remaining prior to the special district election.

The foregoing ordinance is duly passed by the Council of the City of Lakeside, Oregon and approved by the Mayor, this flat day of May, 1981.
