ORDINANCE NO 178

AN ORDINANCE REQUIRING THE REGISTRATION OF CHARITABLE AND RELIGIOUS SOLICITORS OF FOR THE ISSUANCE OF PERMITS THEREFOR.

THE CITY OF LAKESIDE ORDAINS AS FOLLOWS:

SECTION 1. The council of the City of Lakeside hereby finds and determines to proceed on persons going from place to place, or house to house, or business to within the City of Lakeside for the purpose of soliciting moneys or other things or alledged haritable or religious purposes have been conducive to widespread corescention and fraud so that it is necessary in the interest of the public welfare, and refety that the organizations and persons who carry on such solicitations should required to supply information to, and register with, the City of Lakeside before making such solicitation within the corporate limits of the City of Lakeside.

SECTION 2. It shall be unlawful for any organization, society, association, arporation, or person desiring to solicit, or have solicited in its name, money, donations of coney or property, or financial assistance of any kind, or desiring to sell or distribute in them of literature or merchandise for which a fee is charged or solicited from persons where then members of such organization, society, association, or corporation upon the streets, in office or business buildings, by house-to-house canvass, or in public places for charitable, religious, educational, or philanthropic purposes, without having first registered with the City decorder of the City of Lakeside and filed a sworn application in writing on a form to be furnished by the City Recorder, which shall give the following information:

- (a) The name and purpose of the organization or cause for which the solicitation is to be made.
 - (b) The names and addresses of the officers and directors of such organization.
 - (c) The address and telephone number, if any, of the organization, association, cause for which solicitation is to be made.
 - (d) The period during which the solicitation is to be carried on.
- (e) Whether or not any commission, fees, wages, or emoluments are to be expended in connection with such solicitation, and amounts thereof.

Upon receiving such statement, the City Recorder shall immediately cause an investigation to be made, and upon being satisfied that such organization, society, association corporation, or cause is religious, charitable, patriotic, educational, or philanthropic organization, he shall then forthwith issue a permit without charge to such organization, association, society, corporation, or person to solicit within the City of Lakeside. Such organization, society, or corporation shall furnish all of its members, agents, or representatives who will conduct such solicitation with credentials in writing stating the name of the organization, name of the agent and purpose of the solicitation, and the number of the permit issued by the City Recorder.

SECTION 3. In the event that any citizen of the City of Lakeside shall have reasonable cause to believe that the organization or cause is not in fact a religious, tharitable, patriotic, educational or philanthropic organization or that the solicitations hade are misleading, mis-represented, or fraudulent, then he may petition the Recorder for the City of Lakeside for a hearing, and notice thereof shall be given to the organization or person making such solicitation to appear at a hearing to be held not less than 24 hours after the delivery of such notice and the Recorder shall hear and determine said cause and either sustain or revoke the permit for such solicitation. Any petitioner or person holding a permit may appeal the decision of the Recorder to the City Council at its next regular meeting filing notice thereof with the Recorder and serving notice thereof on the petitioner or person holding the permit at least five days before the meeting of the Council.

SECTION 4. Violation of, or failure to comply with, any provision of this nance is punishable, upon conviction, by a fine as set by resolution.

SECTION 3. The foregoing Ordinance was duly adopted by the Council of the knowlee, Oregon, on the 16th day of July, 1981.
