A RESOLUTION SETTING STAFF WAGES FOR FISCAL YEAR 2008-2009

BE IT RESOLVED, BY THE COUNCIL FOR THE CITY OF LAKESIDE, OREGON AS FOLLOWS:

WHEREAS, Funds have been budgeted for the below stated wages; and

WHEREAS, wages set separately for the budget document by action of the City Council; and

WHEREAS, the wages that were adopted fiscal year 2008-2009 are to be increased 4% per year cost of living adjustment for most permanent city employees.

NOW, THEREFORE BE IT RESOLVED, that the city staff wages for the below named individuals are approved effective July 1, 2008 through June 30, 2009. Wages for the positions, which became vacant during the fiscal year, will be redetermined by the City Council.
