

## RESOLUTION 10-11

### A RESOLUTION SETTING STAFF WAGES FOR FISCAL YEAR 2010-2011

BE IT RESOLVED, BY THE COUNCIL FOR THE CITY OF LAKESIDE, OREGON AS FOLLOWS:

WHEREAS, Funds have been budgeted for the below stated wages; and

WHEREAS, wages set separately for the budget document by action of the City Council; and

WHEREAS, the wages that were adopted fiscal year 2010-2011. Wages have a 2% per year cost of living adjustment for most permanent city employees.

NOW, THEREFORE BE IT RESOLVED, that the city staff wages for the below named individuals are approved effective July 1, 2010 through June 30, 2011. Wages for the positions, which become vacant during the fiscal year, will be redetermined by the City Council.


Watershed Coordinator and Stream Surveyors wages are in accordance with approved grant amounts with a 2% Cost of Living Increase.
